CHECKLIST



FACTS Grant and Aid Assessment will conduct a financial needs analysis for each CCS family applying for G.C.Y.L.S. tuition assistance. Once you have submitted your online financial aid application and fee **and** all required documentation to **FACTS**. Any family applying for financial aid **must**:

1. Complete a FACTS application online at www.factsmgt.com. **The following information is REQUIRED for FACTS to process your application by Friday, March 19, 2021:**
 - Completed online application along with the \$35 application fee (paid online to FACTS)
 - Copies of 2020 Federal tax forms, including all supporting tax schedules (Must be the 1040 or 1040ez form, not a preview or summary of taxes.)
 - Copies of 2020 W-2 form or Self-employed form 1099 for both parents/guardians
 - Copies of supporting documentation for social security income, welfare, child support, food stamps, workers' compensation and TANF
 - Current, active email address
 - If any of the above is incomplete, your application will not be processed and an award may not be granted.**
2. Have tuition payments up-to-date with no outstanding balance at the beginning of the school year.
3. Each student remain in *good behavioral standing, with a 2.0 GPA or higher.*

NOTES

- *It is the applicant's responsibility to notify FACTS of all updates to contact information (phone numbers and email), as this is how you will be notified.*
- *Families foreseeing financial need should prayerfully explore all possible sources of alternate funding, not just the financial aid program.*
- *Awards apply to tuition only. Does not apply to registration fee, books, etc.*
- *No other discounts will be available if you are applying for financial aid. This includes employee discounts.*
